# NPP Transportation Member Registration



Transportation companies can access discount pricing on Verizon Wireless service and products through NPP membership. The discounts available to NPP Transportation Members include:

- Corporate Discount **22% discount** on firm/corporate monthly access fees (five line minimum, two corporate lines required to qualify).
- Employee Discount Up to **18% discount** on eligible wireless calling plans \$34.99 and higher (15% discount, plus 3% if enrolled in online billing and My Verizon).
- Select Accessory Discount 25% off eligible Verizon accessories.
- \$20 for 3GB data on 3G/4G devices for corporate subscribers.
- \$30 for 5GB with Mobile Hotspot on 4G smartphone devices.
- Text Message Offer 250 for free, \$5 for 500, or \$10 for unlimited (does not include picture/video or mobile to mobile messaging).
- Existing Verizon Wireless customers are not required to extend their contract to receive the discount.

## HOW TO REGISTER

Signing up to be an NPP member is free and easy.

#### STEP 1


Register at www.mynpp.com.

- Click on "Join Now."
- Select "Company."
- Select your Market Segment and your association (if applicable) from the dropdown menu. (See Figure 1, right.)
- Complete required information (including Verizon Wireless rep name.)
- Your NPP username, password and member ID will be emailed to you within 48 hours from NPP.
- To help expedite the registration process, please include your Verizon Wireless rep information. (See Figure 2, right.)

### **ELIGIBLE COMPANIES**

The member must derive all or substantially all of its revenue from providing transportation services:

- Commercial and residential waste transportation, distribution (auto parts, beverage, chemicals, construction materials, electronics and food), domestic courier service, fleet and container shipping, limousine, long-haul and semi trucking, paratransit, passenger transportation, taxi (both land and water), third party logistics and freight forwarding, towing, and tug and barge operators.
- Eligibility shall also be extended to associations or unions within the transportation industry, provided said association or union's membership primarily represents those eligible members under the definition.







#### **STEP 2**

Upon receiving your login credentials, return to www.mynpp.com to access the Verizon Wireless Agreement.

- Under Vendor Discounts select "Verizon Wireless."
- Click on the "Click here to begin enrollment process" link. If you do not see this link, call National Purchasing Partners at **1.800.810.3909**.
- The Verizon Wireless site works best with Internet Explorer; you may find minor difficulties with Firefox, Safari and other browsers. (See Figure 3, right.)

#### STEP 3

Once on Verizon Wireless site:

- The gray areas will auto-populate with your company's contact information.
- Complete the remaining required information.
- Click "View Agreement."

#### STEP 4

- Check the box identifying that you're an authorized party. (See Figure 4, right.)
- Check the box that indicates that you've reviewed the agreement.
- Click "Accept Agreement."
- Upon accepting the new agreement, please allow 5 business days for processing.
- Although the discounts will be applied to existing accounts immediately, it could take up to 2 bill cycles for the discounts to appear on your statement.
- For questions throughout the enrollment process, please contact your local Verizon sales representative.

### EMPLOYEE DISCOUNT

After a company has registered with NPP and created its business profile, employees can access their individual discount (non-corporate phones). Please have employees go to **www.verizonwireless.com/discounts** and follow the instructions.
